Dear Fatima Parents

We hope this letter finds you well. As we prepare for the upcoming academic year, we would like to inform you about some important changes regarding school fees for 2025.

After a thorough review of our operational costs, capex expenditure and the need to maintain the high standard of education and facilities, it was necessary to implement a fee increase from the start of the 2025 academic year.

We understand that this may have an impact on your financial planning, and we want to assure you that this decision was made after careful consideration of the many costs associated with the operation of an independent school; the Board has approved a 8.5 % increase, effective I January 2025.

Your consistent payment of fees has enabled the school to successfully complete the refurbishment of the new Foundation Phase and Functions Room, the building of the Sports Office and the upgrade of the electrical infrastructure that serves the main school.

The adjustment to fees will enable the school to continue offering quality education, the on-going upgrade of facilities. The focus for 2025 will be on the refurbishing of the high school classrooms, the roll out of further green projects, and the long-awaited purchase of a new school bus.

We value the trust you have placed in the Management and Board, and we remain committed to your child's academic and personal development at Our Lady of Fatima Dominican School.

The Board of Governors thanks you for your continued support.

FEE INFORMATION - 2025

Please find included:

Please note the following important information:

- I. It is the responsibility of the parents to ensure that the school always has your correct contact and correspondence details.
- 2. Fees are due in the month that they are billed. Statements with fees / balances owing are emailed every month. Nil balance or credit balance statements are not automatically emailed.
- 3. The school receives no other income or funding other than from fees billed to parents.
- 4. In order to safeguard our learner's, we are a cash free zone.
- 5. **Debit orders are for school fees and aftercare fees only**. All excursions, tours and other charges must be paid directly into the school account.
- 6. When making payments into the school account please use your **child's surname and name** as a reference or the account number on your statement.
- 7. Debit orders run from 2 January to 30 November annually. Returned debit orders are not re-run. Catch up payments must be made directly into the school bank account.
- 8. Interest is charged on amounts owing older than 60 days at the end of each term.
- 9. Amounts paid via KARRI only reflect on your account once the event is closed on the app.
- 10. Transport is offered mornings only and departs from Tiffany's, on the North Coast, at 06h30 sharp! Please note that transport is a 11-month charge. No casual rates are available.
- 11. All fees must be settled in full by 30 November of each year.
- 12. Fees not settled by 30 November will be handed over for collection and could result in your contract being terminated.
- 13. Text books not returned at the end of November will be billed to the December account.
- 14. Should your daughter not be returning to Our Lady of Fatima a full terms notice is required in **writing to Mrs Lourens**. Fees in lieu of notice will be charged for short notice periods.
- 15. Credit card payments are accepted at reception, except for annual payments.
- 16. We do not accept Diner's or American Express cards.
- 17. Please return all relevant completed pages marked for the attention of the Bursar, Mrs Odendaal by 15 November 2024. Alternatively, the forms can be emailed to jodendaal@fatima.co.za by 15 November 2024.

SIBLING DISCOUNTS DO NOT APPLY TO THE OLDEST CHILD IN THE FAMILY. In the case where there is more than one child, the oldest child pays the full rate and the younger siblings pay the sibling rate. SIBLING DISCOUNTS ARE NOT APPLICABLE WHERE THE CHILD IS IN RECEIPT OF A BURSARY.

Fees are due in advance, that is, in the month that they are charged. Please ensure that all EFT proof of payments are emailed directly to <u>jodendaal@fatima.co.za</u>, the Bursar, **not to any other Fatima email address**.

PLEASE NOTE: ONLY THE FOLLOWING METHODS OF PAYMENT ARE ACCEPTABLE.

- 1. **ANNUAL**: Full amount to reflect in the school bank account on or before 31 January 2025. The annual fee already has the early settlement discount incorporated into it. The amount reflected under Annual is the full amount you must pay if you choose the annual fee payment option. Should the annual fee not reflect in the school bank account by 31 January your fees will automatically revert to monthly fees. *Credit cards are not accepted for the discounted option Thank you.
- 2. **MONTHLY**: Debit orders are signed for the Ist, 7th, 15th, 27th or 31st of the month. This will continue for the duration of the student's schooling at Our Lady of Fatima Dominican Convent School. Monthly payments are due at the beginning of January through to the beginning of November. Each September statement of accounts will reflect fees outstanding for the remainder of the year.

N.B. DEBIT ORDERS MUST BE SIGNED AND WILL CONTINUE FOR THE DURATION OF THE STUDENT'S SCHOOLING. WE MUST BE NOTIFIED IN WRITING OF ANY CHANGES TO BANKING DETAILS 6 WEEKS PRIOR TO THE DEBIT ORDER DATE.

Text books are ordered each October and collated during the December holidays to ensure a smooth start to the following academic year.

EXCURSIONS AND SPORTS TOURS 2025

The cost of overnight Grade excursions (Gr 4 - 11) and sports tours will be communicated and published closer to the date of these tours taking place.

The cost of these excursions and tours must be settled in full before your daughter will be allowed to attend. **NB**: Any deviation or change from the bookings made by the school for any tour will be for the parent's direct cost to the relevant agency. The school will not be responsible for the cost of any changes requested by parents.

Debit orders are <u>not</u> adjusted for excursions, sport tours fees or any other charges. These costs must be paid directly into the school account using your daughter's surname and name as a reference.

There are several sports tours taking place in 2025 for the following sporting codes – Hockey, Aquatics and Netball. Details of these tours will be communicated to parents directly from the Sports Department.

AFTERCARE INFORMATION 2025

Aftercare is available for Grades I to 5 and starts on the first day of each term.

AFTERCARE UNIFORM:

YELLOW aftercare shirt (Uniform shop) & BLUE PE shorts, (no skirts) BLUE or BLACK tracksuit pants or BLUE jeans for cold weather. BLUE school jersey for colder weather.

SECURITY:

Parents must please phone Mrs Caroline Lynch (074 902 0605) BEFORE 11h00 if their daughter is not going to be attending aftercare for any of the following reasons:

- She is absent from school.
- She is going straight home after school.
- She is being collected by someone else other than her parent or sister.
- O She is going to a friend's house after school or after aftercare.

Please do not ask the school reception or a teacher to relay a message to aftercare, it is essential for you to speak directly to Mrs Lynch.

- Parents must please collect their daughter from the aftercare teacher on duty as no child will be sent to the car park or the Kenneth Kaunda Road gate.
- Only persons nominated on the aftercare enrolment form will be permitted to collect and sign for a child. Children will not be released to any other persons.
- o Please inform us promptly of any change in your home, work or cell numbers.
